## **Purpose**

The purpose of this agenda item is to provide information to the Governing Board on the proposed changes to the MLDS 2016 Data Inventory for Governing Board approval at the December Governing Board Meeting.

## **Background**

The MLDS Governing Board is required to create an inventory of individual student and workforce data proposed to be maintained in the system (Md. Ed. Art. §24-704(g)(6)). Additionally, the data inventory serves to inform the public about the contents of the MLDS database. The MLDS Data Inventory – December 2016 details the data proposed to be maintained, or removed from the System.

## **Changes to the Data Inventory**

As a result of publishing the Data Inventory in a dynamic format, this document will only include substantive changes for each of the domains. Substantive changes are inclusions or removals of data elements in the Data Inventory.

Administrative changes are made annually and include the following:

- Clarification to the database in which the data element is maintained (i.e. ODS or MDM)
- Corrections and consistency in [Common Education Data Standards](#) (CEDS Version 6.0) Global ID for the Data Element
- Consistency in reporting the Element Name

## **Summary of Proposed Inclusions**

### *Workforce:*

There are no additional Workforce data elements at this time.

### *PK12: Assessments*

One data element was missing from prior approval of the Assessment data elements. Assessment Test Date has been included to align to the data submission from MSDE.

### *PK12: DECD (Division of Early Childhood Development)*

MLDSC Staff have reached out to MSDE and the Division of Early Childhood Development to begin collecting the Kindergarten Readiness Assessment (KRA) data.

*PK12: HSSC (High School Status and Completers)*

MSDE has begun collecting additional fields in the High School Status and Completers data collection to capture students' College and Career Readiness Determination.

*PK12: SSDS (Standard Student Demographic String)*

MSDE maintains a Standard Student Demographic String that is reported on all data submissions to and from MSDE. The Data Inventory did not clearly cite these fields from MSDE. Additionally, MSDE is in the process of revising the Standard Demographic String to include new data elements.

*PK12: USIS (Unique Student Identification System) and UTIS (Unique Teacher Identification System)*

Each teacher and student in Maryland's public school system is assigned a unique identifier called a SASID for students and a SATID for teachers. Occasionally, it is discovered that a student or teacher was assigned multiple unique identifiers. In these cases, MSDE and the local school systems thoroughly research the identities. If it is determined that the identities are the same, the unique identifiers are merged together. MSDE is providing these data elements to the MLDS to assist with identity matching. These data elements will only be maintained in the Master Data Management system.

*Postsecondary: MHEC\_4 and MHEC\_5*

MHEC is updating their data collections to accommodate revisions to the SAT assessment, including a data element for the new SAT mathematics score, and the new SAT Evidence Based Reading and Writing Score. Additionally, MHEC is including a flag to identify the link between their End-of-Term (EOT) and Enrollment Information (EI) data collections. The data elements for inclusion in the Data Inventory are detailed in the table below.

### **Summary of Proposed Removals**

#### *Workforce: Quarterly Wage File and UI Claimant*

MLDS Center recommends removing six data elements that are not in use in the System. These data elements include parts of addresses and telephone numbers that are not relevant to the work of the MLDS. MLDS Center recommends removing six data elements that are not in use in the System.

- Employer Address Line 3
- Employer Phone Number
- Address Line 2

#### *PK12: Attendance*

There are three data elements are no longer collected by MSDE and are no longer provided to the MLDS.

- Cohort Year
- Non-promotion reason
- Cohort Graduation Year

#### *PK12: SCGT*

There are three data elements are no longer collected by MSDE and are no longer provided to the MLDS.

- Prior to Secondary Course Identifier
- Course Grade Point Average Applicability
- Staff Member Identification System

#### *PK12: Staff*

The Faculty and Administration Performance Level School data element was approved by the MLDS Governing Board for inclusion in the System, but after review was determined to not be appropriate to provide to the MLDS.

- Faculty and Administration Performance Level School

#### *Postsecondary*

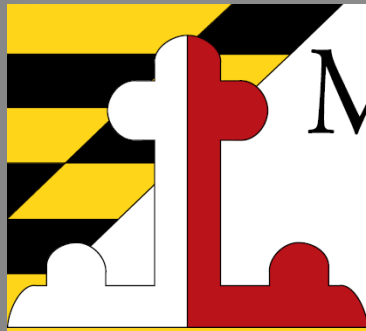
There are no removals of Postsecondary Data Elements at this time. The revised data inventory clarifies the inactive data sources that have not yet been provided to the MLDS.

## **Overview**

The Maryland Longitudinal Data System (MLDS) is Maryland's central repository for comprehensive data from all levels of education and into the State's workforce. The MLDS Governing Board is required to create an inventory of individual student and workforce data proposed to be maintained in the system (Md. Ed. Art. §24-704(g)(6)). Additionally, the data inventory serves to inform the public about the contents of the MLDS database. This document provides a comprehensive summary of data elements proposed to be maintained, or removed from the System.

## **Process**

The development of the Data Inventory is a collaborative process between DLLR, MSDE and MHEC, and the Data Advisory Group members. The MLDS Data Advisory Group annually reviews the Data Inventory and identifies what data elements to propose for inclusion or remove from the System. All data must be relevant to answering one of the questions in the [Research Agenda](#) or generally identified as necessary for evaluating federal or State supported education programs. Data elements identified for inclusion or removal in the System are presented to the Governing Board for approval. Once approved, the requirements are developed with the agency and included in the data collection calendar.

## **Accessing the Data Inventory**

Beginning in December 2016, the MLDS Data Inventory will be available online through the MLDS Center [website](#). This change allows the inventory to be more dynamic, by presenting the inventory in a way that may be organized according to the user's needs.

## **Changes to the Data Inventory**

As a result of publishing the Data Inventory in a dynamic format, this document will only include substantive changes for each of the domains. Substantive changes are inclusions or removals of data elements in the Data Inventory.

Administrative changes are made annually and include the following:

- Clarification to the database in which the data element is maintained (i.e. ODS or MDM)
- Corrections and consistency in the CEDS Global ID for the Data Element
- Consistency in reporting the Element Name

## **Student Data**

State law (Education Article §24-701, Annotated Code of Maryland) defines student data to mean data relating to student performance, including the following:

- State and national assessments;
- Course-taking and completion;
- Grade point average;
- Remediation;
- Retention;
- Degree, diploma, or credential attainment;
- Enrollment; and

- Demographic data.

The law specifically prohibits the Center from collecting data on students from juvenile delinquency records, criminal and Child In Need of Assistance records, medical and health records; and discipline records.

### **Workforce Data**

State law (Education Article §24-701, Annotated Code of Maryland) defines workforce data as data relating to:

- Employment status;
- Wage information;
- Geographic location of employment; and
- Employer information.

### **Understanding the Fields in the Data Inventory**

**Approval Status** – identifies the Governing Board approval status for the Domain, Entity, or Element. Approval Status may either be ‘Approved’ or ‘Proposed’ for approval by the MLDS Governing Board for collection by the MLDS Center.

**Approval Date** – date that the Governing Board approved the inclusion of the Data Element to be maintained in the System.

**Availability** – the earliest date that the Data Element is available to the MLDS.

**CEDS Global ID** – is the Common Education Data Standards unique identifier for the data element. Data elements in the MLDS database are mapped to the [Common Education Data Standards](#) (CEDS Version 6.0) when possible. CEDS represents a national, collaborative effort to develop voluntary, common data standards across the P-20W pipeline and provides nationally recognized naming conventions and definitions. Where data cannot be mapped to CEDS 6.0 standards, alternate domain, entity, and element names are provided, if applicable.

**Database** – an indication of the location of the data element within the MLDS. Data elements are either in the Operational Data Store (ODS) or the Master Data Management (MDM) database. The MDM database contains confidential and sensitive information on student and workers and is restricted to specified authorized staff of the MLDS Center. The ODS contains sensitive, de-identified information on students and workers and is restricted to authorized staff of the MLDS Center.

**Description** – a description of the Data Element that provides additional information related to how the data element is collected, used, or defined in the System.

**Domain** – Domains indicate the sectors that are part of the MLDS: primary and secondary education (PK12), postsecondary, and workforce. The Data Inventory contains both internal and external domains. Internal domains relate to the MLDS partner agencies that provide student and workforce data directly to the MLDS through a memorandum of understanding. MLDS partners include: Maryland State Department of Education (MSDE), Maryland Higher Education Commission (MHEC), and Maryland

Department of Labor, Licensing and Regulation (DLLR). External domains are publicly available information or are provided through a memorandum of understanding with the external entity. Data from external sources are used to enhance the data received from internal sources, and provide additional context to the data in the System.

Internal domains include:

- Workforce,
- Postsecondary,
- PK12.

External Domains include:

- Integrated Postsecondary Education Data System (IPEDS),
- U.S. Census Bureau (CENSUS), and
- Motor Vehicle Administration (MVA).

**Element Name** – describes the data element provided to the MLDS. These are attributes of the Entity. This may be the name used by the partner agency, or a standard name used by CEDS.

**Entity** – Entities represent persons, places, events, objects or concepts about which the data is collected or shared. The Entities in the MLDS Data Inventory are:

**Load Status** – provides an indication of the status of the data element within the MLDS. *Active* data elements are loaded into the System and are currently in use. *Inactive* data elements are approved for use by the Governing Board, but are not currently used in the System for any of the following reasons:

- Not yet loaded into the MLDS, or
- Not yet provided to the MLDS.

*Removed* data elements have been eliminated from the System even though they may have been approved by the Governing Board for use. Data elements are removed for the following reasons:

- No longer collected by the partner agency, or
- Collected by the partner agency for their internal use but has limited or no use to the MLDS.

**Source** – indicates the origin of the data for the specific Domain. This may be the name of the data collection administered by the agency or the table name. The source is specific to the agency providing the data to the MLDS.



## Workforce

Workforce domain data is provided to the MLDS from the Department of Labor, Licensing and Regulation (DLLR).

### Proposed Sources

There are no proposed workforce data elements at this time.
