SUBJECT: MLDS Data Collection Calendars 2024-2025 Academic Year

### **Purpose**

The purpose of this agenda item is to provide information to the Governing Board on the revised MLDS Data Collection Calendars for the 2024-2025 academic year.

### **Background**

The MLDS Center receives data submissions from each of its data sharing partners throughout the academic year. The Data Collection Calendars provide a comprehensive timeline of the files submitted to the MLDS Center by data sharing partners and an accountability process if files are not received within the approved timelines.

### **Creation of the Calendars**

The Data Collection Calendars are revised annually in consultation with the Data Governance Advisory Board (Data GAB). Data GAB membership includes a data steward and data manager from the MLDS Center's data sharing partners.

MLDS Center staff work with the data managers and stewards to set a data collection calendar that aligns with the needs of both the data sharing partner and the MLDS Center. Any new collection or collections in development are added to the calendar.

### **Updates**

- The Maryland Higher Education Commission has changed the name of the Noncredit Workforce Completer System to the Workforce Training Completer System and added a new collection: the Workforce Training Registration System.
- The Student Course Registration System from the Maryland Higher Education Commission is added in place of the previous Course Information System and Student Registration System collections.
- The Microsoft certifications data collection from Certiport is now added to the calendar.
- The Nursing license data collection from the Department of Health is now added to the calendar.

### **Action**

We request the Governing Board approve the MLDS Data Collection Calendars for the 2024-2025 academic year.

## 1. Overview

The Maryland Longitudinal Data System (MLDS) Center collects submissions from each of its data sharing partners throughout the academic year. This document provides a comprehensive timeline of the files submitted to the MLDS Center by data sharing partners and an accountability process if files are not received within the approved calendar. MLDS Center data sharing partners include:

- Maryland State Department of Education (MSDE);
- Maryland Higher Education Commission (MHEC);
- Maryland Department of Labor (Labor);
- Maryland Department of Juvenile Services (DJS);
- Department of Human Services (DHS);
- Motor Vehicle Administration (MVA); and
- Business license issuers and industry certifiers.

The calendar is revised annually through the Data Governance Advisory Board (Data GAB), to allow data sharing partners to align the Calendar to their unique needs.

The MLDS Center staff appreciates the continued collaboration of staff from all our data sharing partners and the Data GAB members.

# 2. Data Calendar Steps

Each submission in the Data Collection Calendar includes a number of steps that are part of the entire process. Each of those steps and the approximate time for completion of that step are detailed below. The specified time periods may be adjusted to accommodate agency needs and priorities.

### 1. Agency Data Verification Complete

Each data sharing partner has a collection and verification process that must be completed by the date established for this step. This date is set by the individual data sharing partners, and is used as a benchmark to set the dates for subsequent steps.

#### 2. Data Received

The date all data are submitted to the Center. Data sharing partners will provide data within 2 weeks after the Agency Data Verification Complete due date. For example, if the data verification complete due date was September 1, 2024 then the data would need to be submitted to the MLDS Center no later than September 15, 2024.

### 3. Data Loading and Comment Period

This step represents the entire collection window for data sharing partners to provide data to the Center. As files are submitted, the Center provides comments to the data sharing partner on data issues. This may include identity matching issues, data verification concerns, general checks of the data as it is loaded into the System, and Data Inquiry form submissions. This period allows the Center to work with the data sharing partner on data related issues. This period lasts approximately 60 days.

### 4. Completion Date

The date all data are loaded into the system.

Note: If an issue is identified after the Completion Date, the MLDS Center will work with a data sharing partner to discuss the situation and, if necessary, come to an agreement on a timeline for resubmission.

## 3. Accountability Process

Detailed below is the process implemented when files are not received within the timeline established in the Data Collection Calendar. The goal of this accountability process is to inform all data sharing partners of the process and create a uniform policy for handling late data submissions. This process was developed in partnership with MLDS Center data sharing partners through the Data Governance Advisory Board.

### 1. Reminder Emails Scheduled

Two weeks prior to the established due date, MLDS Center Staff will send an email reminder about the upcoming data due date to the Data Owner, Data Steward, and/or Data Custodians at the data sharing partner.

### 2. Phone Call

One week after the established due date, MLDS Center will contact the Data Owner, Data Steward, and/or Data Custodians at the data sharing partner.

### 3. Email

Two weeks after the established due date, MLDS Center will contact the Data Owner, Data Steward, and/or Data Custodians at the data sharing partner.

### 4. Email of Notification to Agency Head

Three weeks after the established deadline, MLDS Center Staff will inform the Data Owner, Data Steward, and/or Data Custodians at the data sharing partner that a letter will be sent to the head of the data sharing partner.

## 5. Notification to Agency Head

Four weeks after the established deadline, a letter from MLDS Center Executive Director will be sent to the head of the data sharing partner. The letter will include dates from the established Data Collection Calendar, and a summary of steps 1-3.

### 6. Notification to Governing Board

After the completion of step 4, the Governing Board will be notified in the next Monthly Report to the Governing Board.

### **Request for Extension**

In recognition of the many demands and competing priorities of the data sharing partners, the MLDS Center will work with data sharing partners to establish an extension of the deadline to submit the required files. Once a new deadline has been established, the above notification process will be halted.

### 2024-2025 Data Collection Calendars

If the extended deadline is not met, the notification process begins with Step 4. Except in cases of extreme hardship, deadlines will not be extended beyond two weeks.

# 4. Collections in Development

MLDS Center data sharing partners continuously review the data they collect to ensure the needs of the agencies are met. The cycle from implementation to collection is long and varied. As part of the collection development cycle, MLDS Center data sharing partners will include information on the "Collections Under Development" in their Data Collection Calendar. This ensures that stakeholders are aware of the data that will be provided to the MLDS Center, without placing unreasonable restraints on our data sharing partners to deliver data that may not meet the data sharing partner's data quality standards.
