Maryland Association of Community Colleges (MACC)


MACC is the unified voice for Maryland's 16 community colleges.






Associate's Degree Graduates, State of Maryland, 2012-2013, Distribution by Educational Attainment and Full-Quarter Wages, Five Years after Graduation






Associate's Degree Graduates, State of Maryland, 2012-2013, Distribution by Wage Indicators and Educational Attainment, Five Years after Graduation



Associate's Degree Graduates, State of Maryland, 2012-2013, Distribution by Wage Indicators and Educational Attainment, Five Years after Graduation








Same Employer Full-Quarter Employment



- 93% of Full-Quarter Graduates






Associate's Degree Graduates, State of Maryland, 2012-2013, Industry of Employment, Five Years after Graduation

Summary

- Overall Median Quarterly Wage: \$10,967
 - 70% Above the Living Wage (\$7,841 per quarter)
 - 51% Above the ACS Median Wage for all Workers in Maryland (\$10,872 per quarter)
- Average 2012-2013 Tuition for Associate's Degree: \$7,400
- Comparatively, median quarterly wage for high school graduate, five years after high school graduation
 - No College: \$6,331
 - 34% were above the living wage
 - 16% were above the ACS wage
- Age at Degree
 - 51% are age 18 to 24 (23 to 29 at Q20)
 - 29% are age 25 to 34 (30 to 39 at Q20)
 - 20% over age 35 (39 or older at Q20)

Highlights

- 93% of graduates with full-quarter wages are continuously employed with same employer
 - Education and Health Services: 43%
 - Largest sector for all education groups
 - Median Quarterly Wage: \$12,131
 - 75% Above Living Wage

Highlights

- 27% of Associate's graduates complete at least a Bachelor's degree in five years
 - 62% are visible in the wage data after earning a Bachelor's degree
 - Median quarterly wage: \$11,247
- 17% of Associate's graduates are still in college
 - 63% are visible in the wage data at the five year point
 - Median quarterly wage: \$9,734
 - Cost per year of extending time in college: \$7,000 to
 \$10,000
- 35% of Associate's graduates do not continue a postsecondary education
 - 49% are visible in the wage data
 - Median quarterly wage: \$11,780
